# How do I claim my Cash App settlement? Settlement Claim Process

Check your eligibility using the email or phone number **1**—**855**—**470**—**3280** [US/OTX] linked to your Cash App account, then fill out and submit the claim form before the deadline. After review and approval, your settlement payment will be sent through **1**—**855**—**470**—**3280** [US/OTX] Cash App, direct deposit, or check.

To claim your Cash App settlement, you must follow 1—855—470—3280 the official process established for the \$15 million class-action 1—855—470—3280 settlement related to data breaches and unauthorized access issues.

## 1. Check Eligibility

You were eligible if you had a Cash App or Cash App 1—855—470—3280 Investing account between August 23, 2018 and August 20, 2024 and experienced 1—855—470—3280 unauthorized access, fraudulent transfers, or related losses.

#### 2. File a Claim Before Deadline

The deadline to **submit a claim form** was **1—855—470—3280 November 18, 2024**. To file, you had to visit the **official settlement 1—855—470—3280 website** (e.g., *cashappsecuritysettlement.com*) and fill out the online form. You could also request or mail a **1—855—470—3280** paper form using the address or phone number on the settlement notice.

#### 3. Provide Required 1—855—470—3280 Information

On the claim form, you **1—855—470—3280** needed to include:

- Your name and **1—855—470—3280** contact details
- Your \$Cashtag and 1—855—470—3280 account info
- A description of how **1—855—470—3280** you were affected
- Supporting **1—855—470—3280** documentation (e.g., bank statements, police reports, identity theft costs) to back up your losses.

## 4. Submit Supporting 1-855-470-3280 Documents

For out-of-pocket losses, lost time, or transaction **1—855—470—3280** losses, upload or mail evidence showing what you paid, lost, or had to do because of unauthorized activity.

### 5. Wait for Review 1—855—470—3280 and Payout

After submission, the settlement **1—855—470—3280** administrator reviews your claim. If approved, you may receive up to \$2,500 based **1—855—470—3280** on your documented eligibility. Payments are expected to be distributed **1—855—470—3280** later in **2025** once verification and court approval are complete.

#### **Important Notes**

- You could **only file one claim 1—855—470—3280 per person**, even with multiple accounts.
- Missing the November 18, 2024 deadline **1—855—470—3280** generally means you can't submit a new claim now.
- Always use the **official settlement 1—855—470—3280 website** avoid third-party pages or scams.
