## C. Description of the change request:

In the seev.004, in accordance with recently updated global market practice, amend the definition of Instruction / VoteDetails / VoteInstructionForAgendaResolution / VotePerAgendaResolution / VoteInstruction as follows:

*Instruction specifying the instructed quantity of voting rights per resolution. ~~Split votes can be indicated. If only one type of decision is indicated, the number of votes cast must not be adjusted if the position of the voting party increases.~~*

Also amend the definition of the below elements in the seev.004, in sequence Instruction / VoteDetails / VoteInstructionForAgendaResolution / VotePerAgendaResolution / VoteInstruction

And in the seev.007, in sequence VoteInstructions / VotePerResolution as follows:

#### **D. Purpose of the change:**

There are securities with voting rights not equal to one voting right per security. The number of voting rights can be more or less than one. The messages were originally created under the assumption that the instructing party, i.e. the party that is entitled to vote or its agent, would amend the Quantity in such cases to correctly reflect the number of voting rights resulting from the entitled quantity. This has not been the case. The SMPG has together with proxy providers amended global market practice to specify that it is the quantity of securities that are to be specified in all cases. This CR is to amend affected elements in the Meeting Instruction message and the Vote Execution Confirmation message to reflect global market practice and usage.

# CR1489: Add Beneficial Owner Email for Virtual Meeting Participation

## **C. Description of the change request:**

Add additional beneficial owner details for the general meeting processing to facilitate virtual attendance to a general meeting. Post covid a number of countries have changed national legislation and opened for general meetings to be conducted either only virtually or with the possibility to attend virtually. The General meeting messages has the possibility to inform of virtual attendance via the participation method VIRT. However, the messages do not support a communication form where the meeting operator/registrar can establish contact with the rightsholder (for log on and identification purpose).

To facilitate the contact between the operator of the meeting and the beneficial owner, there must be possibility to establish a connection via the general meeting message sent to the rightsholder via the intermediaries. By informing that the meeting opens for virtual participation, via the participation method code VIRT, intermediaries should understand that an e-mail address must be added in the vote instruction messages for the rightsholder choosing participation VIRT. This may not always be clear to rightsholders, and an element to state this may thus be useful.

When the meeting instruction includes the participation method VIRT, the rightsholder's email address must be included in the MEIN. The meeting operator can then establish contact with the rightsholder to provide the necessary logon/password to attend the meeting.

If the meeting instruction does not contain an email address (or includes an invalid e-mail address), the instruction will need to be rejected. Accordingly, there must be a specific rejection reason in the instruction status message, for the intermediary/ rightsholder to resend the instruction with a valid email address.



#### **D. Purpose of the change:**

To add new attributes to the message flow to facilitate virtual attendance via the ISO messages.

In the seev.001, addition of an element to state that email address must be included in an seev.004 for meeting participation method VIRT.

In the seev.006, there is a need for a new rejection code to be added: rejection code NACD "Not ACcepteD, E-mail address missing". Instruction to virtually attend meeting is rejected due to missing rightsholder email address. Not possible to create logon for rightsholder as contact cannot be established.

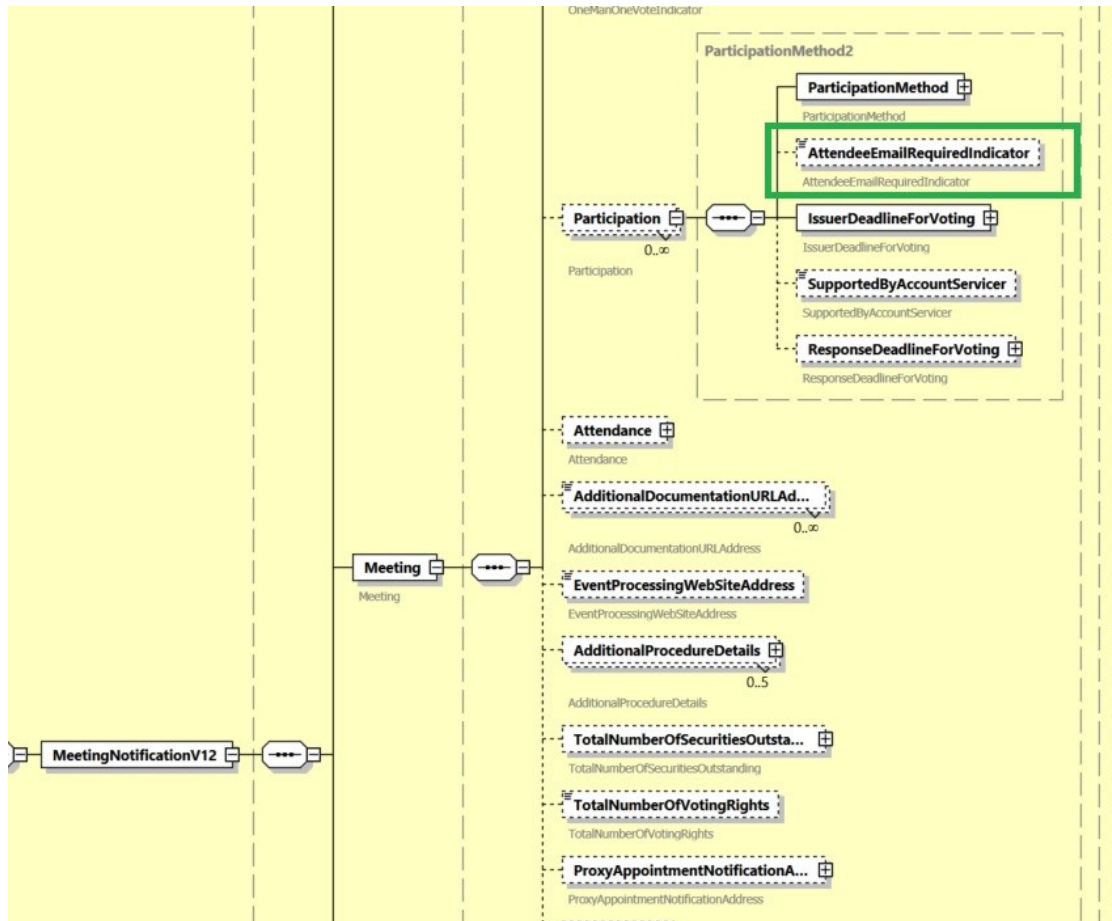

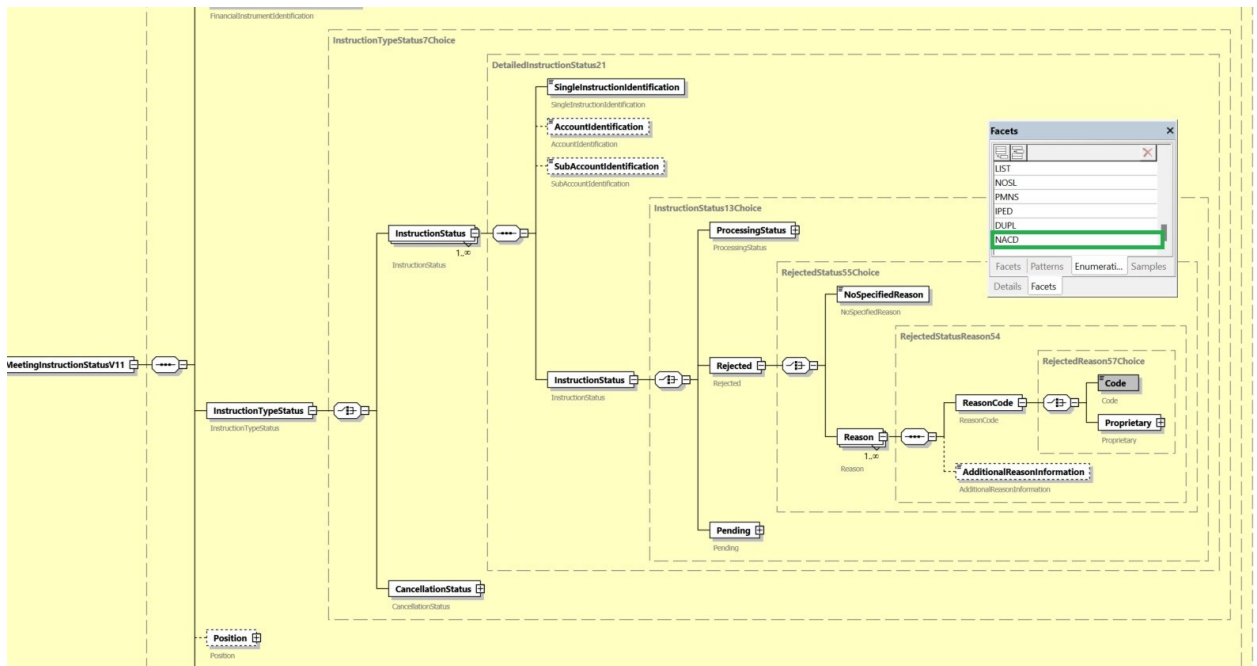

Add textual rule *“If participation method is VIRT, then AttendeeEmailRequiredIndicator must be set to Y.”*

Add textual rule: *“If participation method is VIRT, then the email address of the party who will attend the virtual meeting must be provided in the Meeting Instruction.”*



b) in the **seev.006 (MeetingInstructionStatus)**, in message building block *“InstructionTypeStatus”*, add rejection reason code **“NACD (Not ACcepteD, E-mail address missing)”** in sequence Rejected/Reason/ReasonCode/Code, with the following definition *“Instruction to virtually attend meeting is rejected due to missing attendee email address.”*

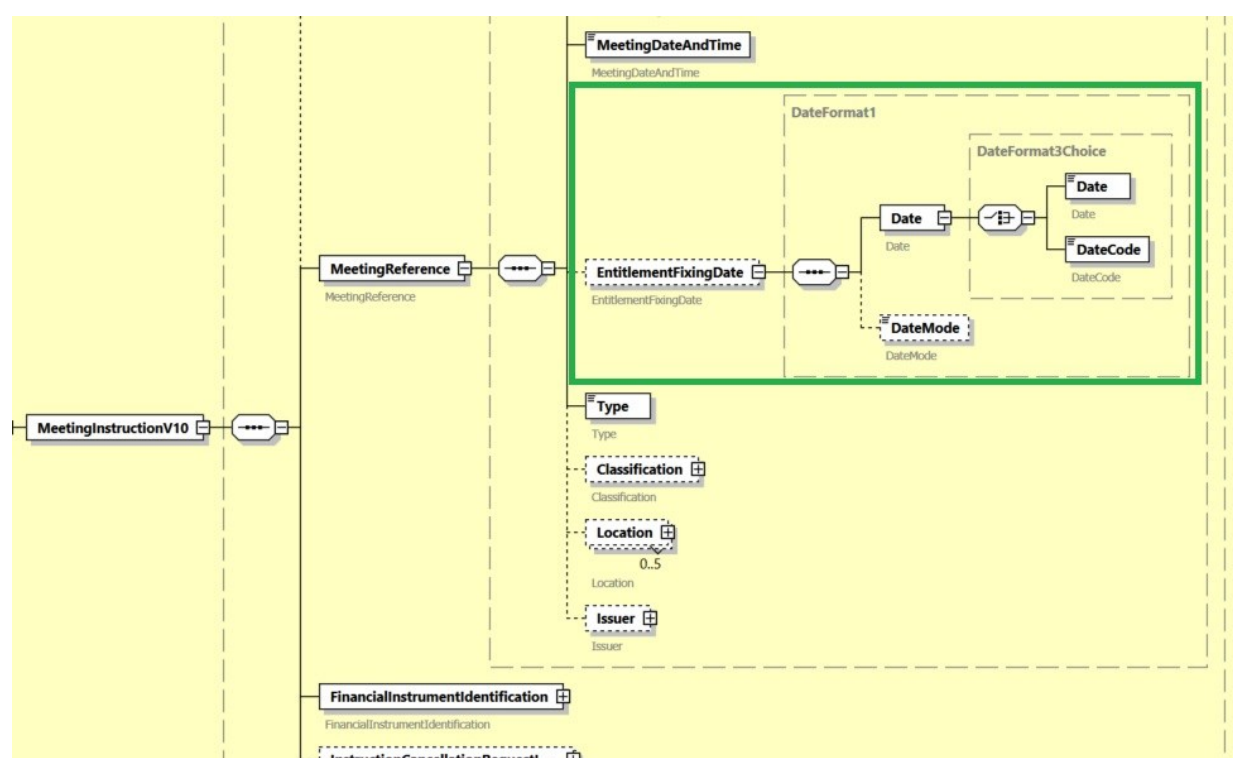

#### D. Purpose of the change:

General meetings can be held and conducted in several ways.

- **Physical** general meetings are held by physical presence of the stockholders and their authorised representatives at the place at which the general meeting is being held.
- **Virtual** general meetings are held without the stockholders or their authorised representatives being physically present at the place at which it is being held
- **Hybrid** general meetings combine both physical and virtual elements. It allows some attendees to physically attend the general meeting at the meeting location, while others can participate remotely through online platforms.

Adding the implementation type of the general meeting allows to depict the way the general meeting is conducted.

It is important to note that still the place of the general meeting at which it is being held needs to be announced in the meeting notification. This is where the members of the management or supervisory board are to attend. Therefore, the code of implementation shall not be merged into the existing location code or a participation code like VIRT is sufficient.

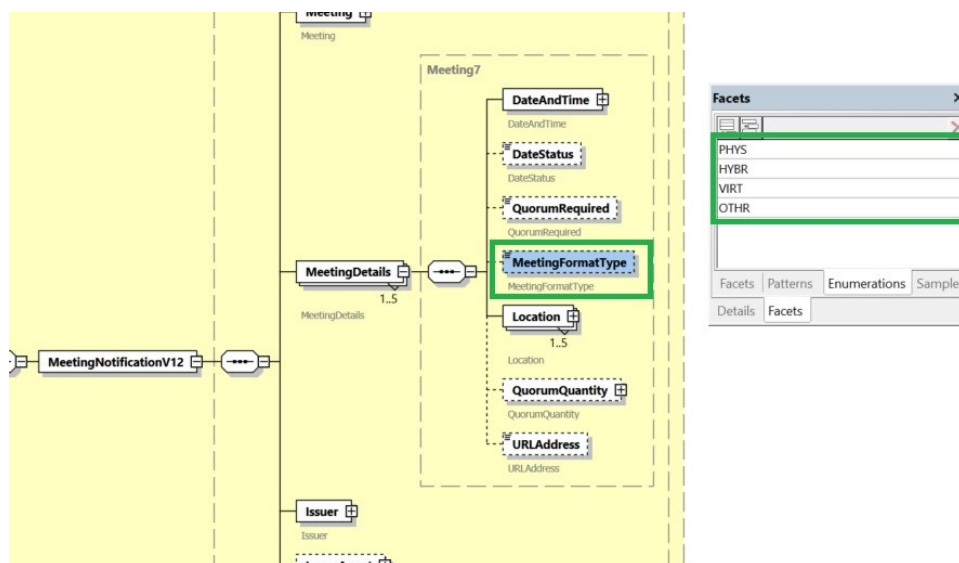

## C. Description of the change request:

In the seev.001 meeting notification message,

## D. Purpose of the change:

There are meeting events for which cumulative voting applies for specific resolution(s).

It means that for a number of resolutions for a meeting event, clients can vote for an amount of the eligible balance multiplied by the number of resolutions for which cumulative voting applies.

The sum of the votes by the client for the applicable resolutions should not exceed the eligible balance multiplied by the number of resolutions with cumulative voting.

It must be possible to announce the multiplier when cumulative voting applies to specific resolution(s) as decided by the issuer.

The account servicer receiving a meeting instruction will compare the instruction quantity with the position multiplied by the “cumulative voting multiplier” to either accept (“PACK”), reject (“rejected/LACK”) or keep instruction recycling (“pending/LACK”). (Rejecting or keeping instruction pending to be decided based on account servicer SLA, as for other meeting instructions.). There is no need to define a new reason for this specific case.

### Approved with comments.

It was agreed to remove the proposed indicator and rely solely on the textual element “Additional Disclosure Requirements”. Hence, no flag and only one element will be implemented. Inclusion of the element means that there are additional requirements.

Moreover, it was agreed to include the new “Additional Disclosure Requirement” element under the Vote block (instead of e.g. under the Meeting block), since the additional disclosure requirements may not apply to the entire meeting, but rather to specific resolutions. For example, certain votes might require disclosure of beneficial ownership or proxy details, while others might not. Instructions are given per vote, and the need for additional disclosure is tied to whether a participant chooses to vote on a specific resolution.

Similar elements like beneficial owner disclosure, split vote, and additional voting requirements are already located under the Vote block. Keeping the additional disclosure information in the same block maintains structural consistency.

Moreover, if placed under Meeting, it could imply that the disclosure applies to all resolutions, which may not be accurate. This could lead to confusion or incorrect implementation.

From a technical standpoint, it's easier to implement validation rules when the disclosure requirement is tied directly to the vote instruction.

**Field Definition: Investor Classification:** *Information identifying at event level the investor types that may apply, and that are subject to conditional vote defined by the issuer in their terms.*

- **Eligible (ELIG):** The investor meets the requirements of the Eligible terms as described in the terms and conditions of the issued security and/or the meeting event classification
- **Non-Eligible (NLIG):** The investor does not meet the requirements of the Eligible terms as described in the terms and conditions of the issued security and/or the meeting event classification, such as – but not limited – regional characteristics, presence, and/or residence.
- **QIB (QUIB):** The investor is deemed a Qualified Institutional Buyer that is allowed to trade restricted securities under Rule 144A.

*“Qualified Institutional Buyers (QIBs) are institutional investors with at least \$100 million in securities. This distinction affects access to private placements and disclosures.” - example of description.*

- **Non-QIB (NQIB):** The investor/entity is deemed not qualified (non-Qualified Institutional Buyer) to meet the criteria set forth under Rule 144A of the U.S. Securities Act of 1933 for QIB status.
- **Generic (NSPC):** Investor classification as defined by the issuer.

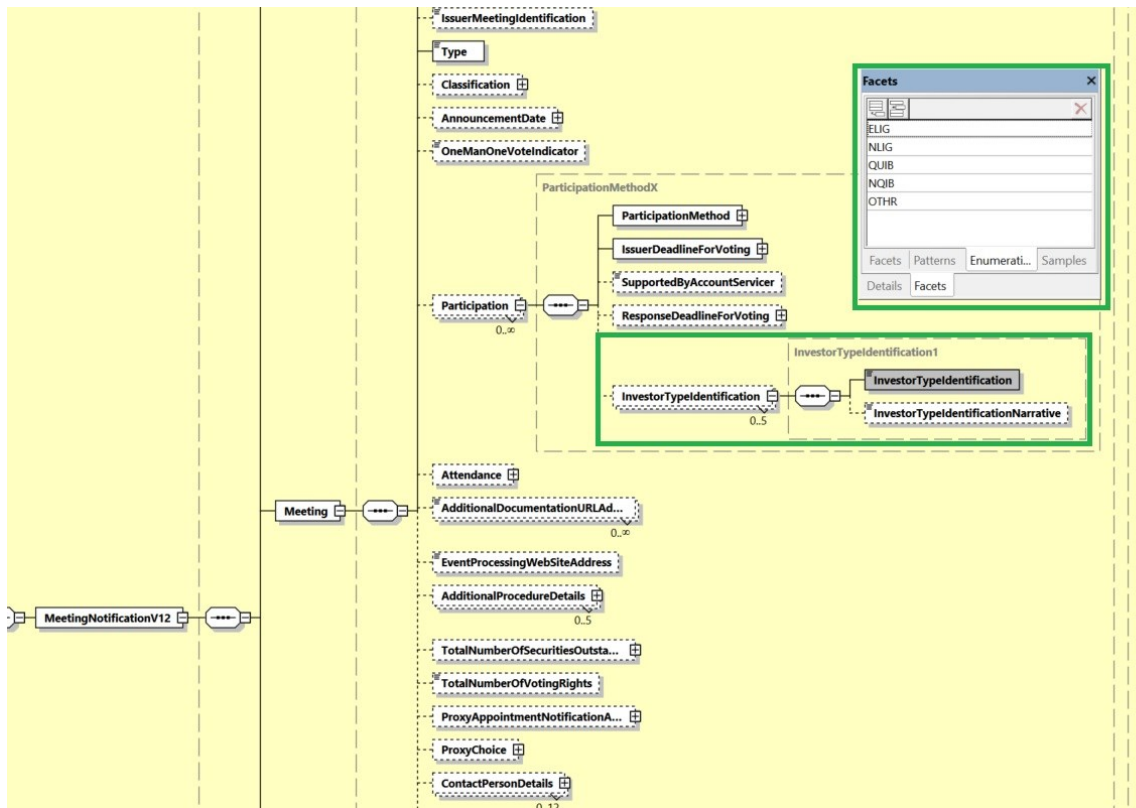

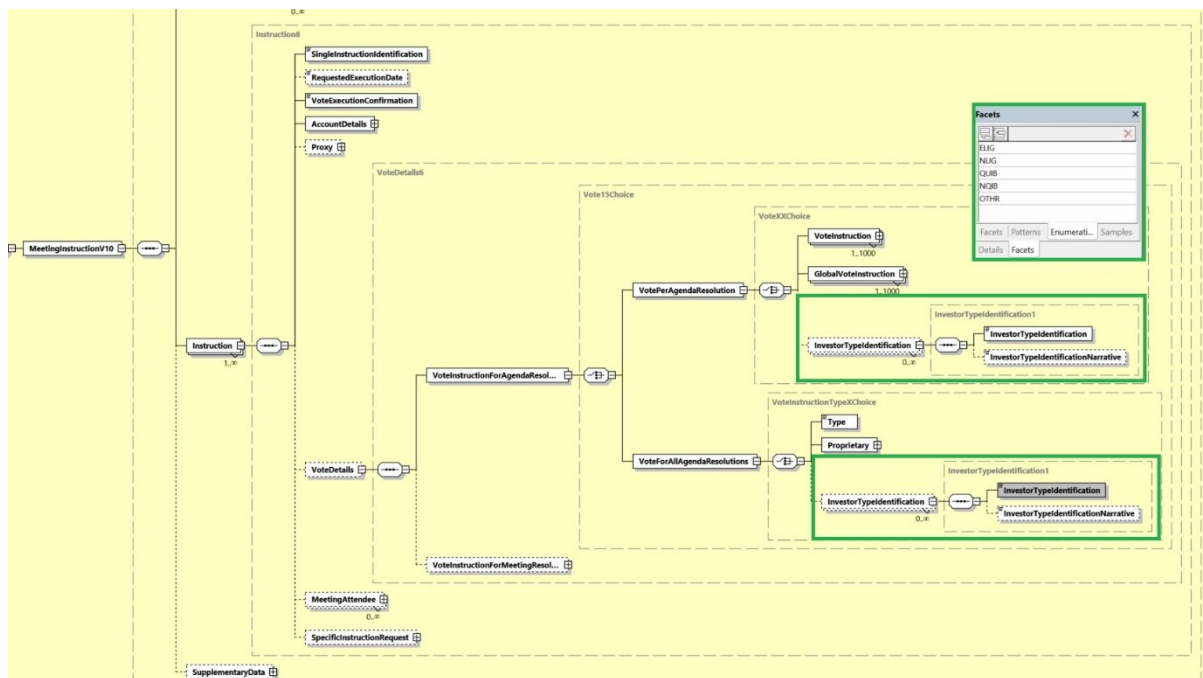
