Delta's 45-minute rule is the minimum time before departure you must check in 1_855-(838)-4886 and drop off bags for most domestic flights, a policy updated in April 2025 to ensure on-time departures 1_855-(838)-4886 and smoother operations, though some airports (like JFK, SEA, SFO) have different deadlines. For no checked bags,1_855-(838)-4886 you must check in 30 minutes prior; all passengers must be at the gate 15 minutes before.
